- Catholic cemeteries are intended for the interment of Catholics who have the right to Christian burial as well as Catholics who have not been active in the Church, individuals of other Christian faiths, and non-Catholic spouses and family members of Catholics (Rules and Regulations, Article 1: Purpose of Cemeteries).
- 2) Roman Catholic cemeteries are holy places, sacred grounds consecrated by the Church, a place of prayer and dignity for our faithful departed, and an extension of the Church. Quiet reverence and respect for other people visiting is expected at all times (*Rules and Regulations, Article XIV: Use of Cemetery*).
